



MODIFICATION No.3 TO THE PRACTICAL ARRANGEMENTS

between

FUKUSHIMA PREFECTURE

and

THE INTERNATIONAL ATOMIC ENERGY AGENCY

on

FUKUSHIMA PREFECTURE INITIATIVE PROJECTS

This Modification No.3 to the Practical Arrangements on Fukushima Initiative Projects is made between Fukushima Prefecture, whose address is 2-16 Sugitsuma-cho, Fukushima City, Fukushima Prefecture 960-8670, Japan; and the International Atomic Energy Agency (hereinafter referred to as the "IAEA"), an intergovernmental organization established by its Statute, whose address is Vienna International Centre, P.O. Box 100, 1400 Vienna, Austria. Hereinafter, Fukushima Prefecture and the IAEA will also be referred to individually as a "Party" and collectively as the "Parties".

WHEREAS the Practical Arrangements between Fukushima Prefecture and the International Atomic Energy Agency on Fukushima Prefecture Initiative Projects were signed by the IAEA on 25 March 2013 and by Fukushima Prefecture on 10 April 2013(hereinafter referred to as "the Practical Arrangements");

WHEREAS Modification No.1 to the Practical Arrangements was signed by Fukushima Prefecture on 25 October 2013 and by the IAEA on 30 October 2013;

WHEREAS Modification No.2 to the Practical Arrangements was signed by the IAEA on 4 April 2016 and by Fukushima Prefecture on 8 April 2016; and

WHEREAS the Parties desire to modify Paragraph 2 ("Scope of Cooperation") of the Practical Arrangements and also to extend the duration of the Practical Arrangements.

NOW, THEREFORE, the Parties have reached a common recognition on the following:

- 1. The duration of the underlying Practical Arrangements will be extended until 31 December 2022.
- 2. Paragraph 2 ("Scope of Cooperation") of the Practical Arrangements is hereby modified to read as follows:

"The Parties have identified the following projects and activities that will be administered by Fukushima Prefecture, for which cooperation may be pursued, subject to Parties' respective mandates, governing regulations, rules, policies and procedures:

- Survey, and evaluation of the effect, of radiocaesium dynamics in the aquatic systems based on the continuous monitoring;
- Survey of radionuclide movement with wild life;
- Sustainable countermeasures to radioactive materials in fresh water system; and
- Study of proper treatment of waste containing radioactive materials."
- 3. Except as provided in Paragraphs 1 and 2 of this Modification No.3, all other paragraphs of the Practical Arrangements will remain unchanged.
- 4. This Modification No.3 will be valid on the date of the last signature by or on behalf of the Parties and will remain valid for the duration of the Practical Arrangements.
